

The system categorically segregates each application according to their subject matter.



Completion of General Assessment and Draft Publication

We are happy to announce that the work of the General Assessment of the Barrackpore Municipality has been successfully completed and the new revised property tax of the holdings within the jurisdiction of Barrackpore Municipality has been put into effect from 1st July 2015. The notice regarding Draft Publication of the General Assessment of Barrackpore Municipality was done by West Bengal Valuation Board on 4th September 2015 in two leading dailies namely:-

- 1. The Times of India.
- 2. Ei Somoy.

It is also informed to all citizen residing within Barrackpore Municipal jurisdiction that after receiving the demand notice of the new tax assessed they can apply for review of tax within 60 (sixty) days from the receipt of demand notice as per the Rule of West Bengal Valuation Board.

Anti-Plastic awareness campaign

In keeping with the Plastic Waste (Management and Handling Rules 2011) this Municipality has enacted a Bye -Law duly approved in the Board of Councilors' Meeting Dated: 27/7/2012.

To give a fully-fledged effort in banning plastic waste and other thermocol made waste this Municipality at present is creating awareness among its citizens through posters, banners, flexes displayed in market areas and vantage locations.
